Countries That Restrict Entry Due to Criminal Convictions

Many countries enforce entry restrictions based on an individual's criminal history. Canada, in particular, denies entry not only for felony convictions but also for certain misdemeanors—a policy that differs from many other countries, which typically focus on felonies.

Since entry rules vary widely, the best way to determine admissibility is by contacting the consulate or embassy of your destination country.

Entry Pre-Approval and Waiver Options

Canada offers unique options for travelers with a criminal record:

- **Deemed Rehabilitation:** Some individuals may be considered rehabilitated based on the nature and age of their offense. This status allows entry without undergoing a formal application process.
- **Application for Rehabilitation:** For those who do not qualify for deemed rehabilitation, an official application must be submitted to the Canadian Consulate. If approved, the entry restriction is permanently lifted. This application requires extensive documentation, including employment and housing history, court records, and a personal statement

regarding rehabilitation. Processing can take a year or longer, and the application fee is approximately \$1,333.87.

- **Temporary Resident Permit (TRP):** If an individual is not yet eligible for rehabilitation, they may apply for a TRP, which grants temporary entry for up to three years. However, this option is recommended only when rehabilitation is not an immediate possibility.

Countries That Make Entry Decisions at the Border

Some nations do not have a preapproval process and instead assess travelers with a criminal record upon arrival. For example, Ireland's Border Management Unit has discretionary authority to deny entry based on past convictions. Unlike Canada, Ireland does not offer a rehabilitation application, meaning travelers are evaluated on a case-by-case basis at the border.

Countries with Automatic Entry Bars

Unlike Ireland's discretionary approach, many nations enforce automatic entry denials based on specific criminal offenses. Examples include:

- **Schengen Area Countries:** Entry is barred for individuals with:
 - A prison sentence of three years or more.
 - A drug trafficking conviction resulting in a sentence of two years or more.
 - A human trafficking conviction.
 - A history of providing false information to border agents regarding their criminal record.
- **United Kingdom:** Travelers are automatically barred if they:
 - Have been sentenced to one year or more in prison.
 - Are classified as repeat offenders.
 - Have committed crimes resulting in serious harm, including violent, sexual, racially-motivated, or drug-related offenses.
